Shipping Terms

Mustang Depot will process all orders received the day after the order is received. We do not guarantee stock. If the item is currently available, the product will ship the day following the order date, with respect to the type of delivery service requested by the customer. (For example; If you order something on Monday selecting the Next Day Air Option, if the product is available, your order will be processed and shipped on Tuesday and you should receive it by Wednesday) This does not include weekends and holidays. We are not liable for shipping charges, for items that are not currently in stock. We will ship the item the manner in which it was ordered (i.e. Next Day, 2nd Day) whenever the product is or becomes available... There are no refunds given for shipping charges! We will do our best to fill orders that we don't have currently in stock. We have a network of affiliates, which allows us the ability to pursue the product from other sources. However, it is not too uncommon for nationwide backorders to be in effect due to manufacturer hold-ups on certain items. The term used herein as "Free Shipping" only applies to "Ship To" addresses within the continental USA only. Return Policy

Within **30 days** of your purchase, items can be returned to Mustang Depot via UPS for a refund. There is a **20% restocking fee** imposed on **all** goods returned for a refund! In-Store Credits can be issued in the full amount of the product, less shipping charges! Shipping charges are always non-refundable! **Either way, it's necessary to obtain a Return Goods Authorization (RGA) number from Mustang Depot.** Obtaining an RGA number ensures that the return process is handled efficiently and that credits are issued in a timely manner. Within 30 days of receipt of items purchased from Mustang Depot customers may choose to return:

- Any new item in original packaging and original/unused condition
- If you install the item(s), it will be deemed un-returnable.
- Any used Core, as long as it is shipped in the box that contained the new product
- Any item received in a damaged or defective condition
- Any item received in a damaged or defective condition.
- Any item received in error.

Goods Not Accepted for a Return

- If you purchase a product and find it doesn't fit due to any modification to the car from stock (ie. Engine Swap, Transmission Swap)
- No return on electrical parts, books, special order items, or items we disclaim in advance...

Obtaining a Return Goods Authorization Number When you plan to return items via UPS to Mustang Depot, **it's necessary to obtain a Return Goods Authorization (RGA) number.** RGA numbers help us process returns quickly and efficiently. Please Call (702) 262-0011 or email customerservice@mustangdepot.com for your RGA number request. Please include the reason for the return, date the order was placed, your order number, name, phone number, and shipping address.

Returning Items to MustangDepot.com Simply take your package to any location that has regularly scheduled UPS pick-ups. You may want to check with your place of employment to see if they have regular UPS pick-ups. Or, you can call 1-800-PICK-UPS (1-800-742-5877) or visit the UPS Web site at www.ups.com/using/services/locate/locate.html. As long as your return address label is attached and the RGA number is included, it will insure the prompt and efficient handling of your return. **Please note: you must insure the item with the carrier for the total amount of the sale!**

Credit and Return Shipping Costs Within 15 business days of receipt of your returned item, you will be issued credit for the original purchase price, plus applicable sales taxes, and less applicable re-stocking charges. Core credits will also be processed within 15 business days.

If the reason for your return was caused by Mustang Depot, or one of our business partners (i.e., damaged or defective items, wrong part shipped), we will cover the freight charges on the replacement items. All other returns (i.e., didn't want, doesn't like) will be limited to the invoiced price less a 20% restocking fee, and less the shipping charges. In-store credits can be issued for the full purchase price of the goods, less shipping charges.
